### **PLANNING COMMISSIONERS' COMMENTS**

Commissioner Garcia asked about current water conservation efforts and proposals; he also asked about the status of the Circulation Element.

Commissioner Nemeth asked if trash bags can be provided for the City sidewalk trash can in front of Coldstone Creamery. He also asked about the Verizon store near Kennedy Fitness and Oak Hill Road and traffic safety (striping/Bots Dots).

Commissioner Treach commented that we propose to develop new parks, yet we can't afford to maintain them.

Commissioner Holstine noted that the Niblick landscape parkway is being overwatered by either the City or a private party.

Commissioner Vanderlip thanked the Commission and staff for their assistance getting him up to speed.

Commissioner Gregory would like the Planning Commission to receive copies of specific plan quarterly reports. He also stated he is encouraged with the rethinking of street and road LOS. He asked about the service station median issue on Golden Hill Road and asked about compliance with towing businesses complying with conditions.

### **STAFF COMMENTS**

Ron Whisenand updated the Commission on the status of the Uptown/Town Centre Specific Plan. He further advised the Commission that the City Council approved a Housing Authority request to process a development plan ("PD") and environmental review for the redevelopment of Oak Park prior to completion of the Uptown Specific Plan.
