Application: Review revised plans for this project.

Location: 612 Olive Street Applicant: Steve Holman

Discussion: Steve Holman presented the revised plans which changed the design of the

home to a two-story plan with a two car garage. This design allows for two tandem parking spaces along the northern property line. The parking for the new rear house and the tandem parking for the front house would all be accessed from the alley. Mr. Holman described the rear yard areas for both units, as well as a walking path that would allow access for each house to the

front to the rear.

Action: The DRC appreciated the re-design and felt that the parking situation was

much better. The DRC recommended that the Planning Commission approve

the site plan as well as the parcel map.

Application: Review project changes since last DRC meeting for resort project. Location: Northeast corner of Experimental Station and Buena Vista Drive.

Applicant: Ayres Hotels / North Coast Engineering

Discussion: The original proposed project included a 40 room expansion wing that would

be built in a future phase. Doug Ayres along with Steve Puglisi presented an alternative plan for the 40 rooms that would be added as a third floor with Phase I, rather than building the future wing. Mr. Ayres would like both options to be approved by the Planning Commission so that he could have the

flexibility to make the decision of either alternative in the future.

Action: The DRC did not see a problem with the proposal. Staff will include an

additional exhibit as Option B for the 40 rooms in the project as it goes

forward for Planning Commission and City Council review.

with the standards.

Application: Review revised plans for detached accessory building.

Location: 312 – 13th Street Applicant: Jason Domingos

Discussion: Jason Domingos presented the revised plans which more clearly showed the

materials of the proposed building. The plans also were revised to show the correct 10-foot setback to the second story. While Mr. Domingos is prepared to construct the building with board & bat siding and composition roofing to match the house, he did request an opportunity to bring some metal siding

samples back to the DRC, prior to the PC meeting schedule for June 12th.

Action: The DRC appreciated the re-design and recommended that the Planning

Commission approve the CUP to allow the building. The DRC will review the alternative siding samples on June 11th, and report back to the PC on the

meeting of June 12th.
