The height and mass of the new design is similar to the original. The applicants explained that the reason for the change was to provide a design that would lend to the amount of equipment that needs to hang from the structure for the performances. Also the original tile roof material was not a good choice for the structure given the

music/vibration that will result from the concerts.

Action: While the design changes to the stage structure are quite different from the

original design, the DRC was comfortable with making a finding of substantial compliance based on the design complementing the colors, materials and general architecture of the existing Vina Robles buildings, and understanding that the changes were necessary to adequately support the

concert equipment that it will need to support.
