Facts:

Needs: To recommend goals for consideration by the City Council as part of its biannual goal-setting and financial planning process.

1. Every two years, following Council elections, the City Council sets goals for the ensuing two years. These goals are used to focus staff efforts and financial planning.

- 2. It has been the Council's practice to conduct a public workshop on a Saturday in February or March. The date for the 2013 has not yet been set, and will likely take place in early March.
- 3. As part of this process, it has been the Council's practice to request suggestions for goals from the various advisory bodies.
- 4. The Council has asked that all advisory bodies provide suggestions for goals by January 25.
- 5. Attached are two documents that help illustrate the goal-setting process. The first is a ranked list of goals considered by the Council in 2011 (dated March 19, 2011); the second is a progress report on the adopted 2011 goals (dated March 27, 2012).
