# 1. <u>Conditional Use Permit 12-007 and Amendment to Planned Development (PD) 05-</u> 012 – CG CNG, Inc.

For the Planning Commission to consider approving an application filed by CD CNG, Inc. (affiliated with Paso Robles Waste Disposal) to establish a compressed natural gas (CNG) card-lock fueling station and to amend the development plan for Industrial Tract 2594 to accommodate the proposed use and architecture. The site is located on Lot 14 of Tract 2594 – on the southwest corner of the outer ring of industrial lots on Combine Street; the site is also located at the eastern terminus of Wallace Drive (APN 025-437-014).

Commissioner Vanderlip announced that he had a conflict of interest with this item and recused himself, leaving the room. Commissioner Gregory acted as Chair Pro Tem.

## 2. <u>Planned Development (PD) 13-001 and Vesting Tentative Tract 3047 - Uptown</u> Center/Rick Jeffrey

For the Planning Commission to consider an application filed by Rick Jeffrey to subdivide a vacant 2-acre site (3328 Spring Street – former Paso Robles Ford site) to develop 28 single family homes, 14 residential condominium units, and 20,500 square feet of commercial space (APN 008-042-011).

The Commission also recommended that the applicant work with the City Engineer to extend angled parking in Spring Street to 32<sup>nd</sup> Street, if technically feasible, and either eliminate or relocate the curb extension shown on the plans at the south end of the angled parking. Any curb extensions determined to be necessary should be designed to minimize potential traffic conflicts and maximize their visibility, particularly at night.

# 3. <u>Conditional Use Permit (CUP) 13-001 – Brett Van Steenwyck</u>
