 - Amended Condition #3 to (a) change the name of the plan from "Dust Control Plan" to "Conditional Use Permit Implementation Plan;" (b) replace Community Development Director with Development Review Committee; (c) change 60 days to 30 days.
 - **2.** Add a condition to limit approval of the CUP to 5 years, with provisions for extensions beyond 5 years.
 - **3.** Add the conditions recommended by APCD if the drive and parking areas are not paved.
 - **4.** Plant a shrub barrier along the 100 foot setback in Pen No. 1, which may wrap around the west side of the horse trailer parking area.
 - 5. Add signs on the driveway setting a speed limit (10-15 mph) and listing contact names and phone numbers for the business.
 - 6. Add dust binding measures at the corner of the driveway from the end of pavement south 30 feet.

2. <u>Conditional Use Permit 14-004 - Armstrong</u>

For the Planning Commission to consider an application filed by Jay and Nancy Armstrong, to construct a 1,146 square foot expansion to an existing 876 square foot detached garage located at 734 Pino Way.
