1. Brett Van Steenwyck and Debbie Lorenz have filed the following applications for the Pine Street Promenade project:

a. PD 14-001 to develop a two-phased project with the following components on the southeast corner of 10th and Pine Streets:

Phase One: 100 - 121 room hotel, 3,600 sq ft of meeting rooms, 11,500 sq ft public

market (retail commercial space), 5,800 sq ft restaurant and surface and

subterranean parking lots;

Phase Two: 400-500 seat Performing Arts Center, 5 level 240 space parking

structure, and 5,400 sq ft office built into the parking structure (these

would replace the surface parking lot).

b. Request to approve a tentative parcel map to subdivide the site into two parcels.

- 2. A Notice of Public Hearing and draft Mitigated Negative Declaration (MND) was published in the Tribune on June 18, 2014 indicating that the Planning Commission would meet on July 8, 2014 to consider the development applications and MND.
