Dear Chairman Vanderlip,

On behalf of the staff and Board of Directors of Habitat for Humanity for San Luis Obispo County, we are writing to thank you for the advice and support you provided for our Vine St. development. Your appreciation of what we were working to achieve and the families we hoped to serve was deeply heartening. It is always a pleasure to be able to work with others who understand Habitat and what our mission is.

The decision to not pursue the project was an extremely difficult and sad one for the Board and staff. Despite our best efforts, finding funding for the project was challenging. The decision by HCD to consider the CalHome funding that we received from the City not as property purchase funding, but as first time homebuyer assistance funding was a serious setback. It eliminated our opportunity to apply for CalHome funding for the project. In addition, competition for HOME grant funding was rigorous and only one grant would be awarded. We were considering pursuing the USDA 502 application program but even if we were accepted into that program the only way we would have adequate funding to complete the project was if we received the HOME grant or the City waived all the fees for the project. Based on our calculations fees we would have had to pay would have been \$75,000 - \$85,000 per house. This is equal to one-third to one-half of the budget for the project. The City had originally awarded us a grant of \$275,000 from its RDA funds to help cover these fees, but the agreement was not considered an enforceable obligation by the State and the funds were lost. However, while those funds would have helped cover the cost of the fees, it would still have been almost \$500,000 short of covering that cost.

The Board and staff reviewed every avenue to determine whether we could find a way to fund the project, but ultimately was unable to find additional funding opportunities we could pursue. We are extremely disappointed that this project is not going to be built. We worked hard to make it an appealing and attractive Habitat community and were very happy to be building in Paso again. We will be continuing our home preservation and neighborhood revitalization programs in Paso, especially in the Sierra Bonita Village Senior Community. Our hope is that we will again build new homes in Paso Robles in the future. We may not have been able to pursue this project, but we definitely see Paso as one of the places where we wish to build affordable housing.
