There was some concern with the site layout and the proximity of the drive through lane with 23<sup>rd</sup> Street and Spring Street. The DRC discussed that there should be a condition of approval with the CUP that final site planning and architectural details go the DRC for approval. That being said the DRC discussed that it will be important for the Commission to discuss the proposed site plan and building design and give direction to the applicant and the DRC if there are any major design issue that would need to be addressed. The Commission may want revised plans to come back to the

Commission.
