Facts:

Needs: For the Planning Commission to consider an amendment to PD 03-012 to allow changes to the existing fascia of the commercial fueling station canopy.

1. The site is located at the northeast corner of Golden Hill Road and Highway 46 East (2400 Golden Hill Road) within Subarea E of the Borkey Area Specific Plan (see location map, Attachment 1).

- 2. The General Plan land use designation is CS (Commercial Service) and the zoning is C3 (Commercial/Light Industrial).
- 3. On March 9, 2004, the Planning Commission approved PD 03-012 allowing for the redevelopment of the Eagle Energy site, which included construction of the new card lock and commercial fuel islands with new canopies, and construct the 4,500 square foot convenience store.
- 4. PD 03-012 established a western architectural theme for the convenience store and the canopies, which includes wood siding, trim, and gable elements. See original canopy elevations, Attachment 2.
- 5. The current gas canopy fascia is coming apart and needs repair. The applicants are requesting the existing canopy fascia be replaced with standard corporate 76 aluminum paneling and new signage. See proposed elevations, Attachment 2.
- 6. The existing building/convenience store and secondary diesel fuel canopy would remain as is.
- 7. The DRC reviewed the request to revise canopy signage and materials on August 17, 2015 and again on October 19, 2015. The DRC recommended that the Commission approve the amendment to allow the canopy change.

Conclusions: Though the proposed canopy fascia design would not be consistent with the original western style architecture for the project, it would be consistent with the Mobil and Pacific Pride canopies located across Golden Hill Road, which also have a standard metal canopy design.

> The DRC recommended that the Planning Commission approve the change in the canopy design based on the proposed design being consistent with the other canopies in the area.





WHEREAS, Planned Development (PD) 03-012 was approved by the Planning Commission in 2004 approving the site planning and architectural character of the re-construction of the Eagle Energy fuel canopy and conveince store, located at 2400 Golden Hill Road; and

WHEREAS, the western architectural theme consisting of board and batt siding, raised parapet was utilized on the conveience store as well as both the fuel island canopies, and in addition the free standing carwash building; and

WHEREAS, the materials on the primary fuel island canopy are worn and need replacing and the applicant is requesting that the style and materials of the façade of the primary fuel island canopy be changed to the standard type aluminum paneling (ACM) along with new signage for the 76 fuel sales; and

WHEREAS, the existing fuel island canopy for the diesel fuel is not proposing to be changed; and

WHEREAS, a public hearing was conducted by the Planning Commission on December 8, 2015 to consider facts as presented in the staff report prepared for the amendment request, and to accept public testimony regarding the application, and

WHEREAS, based upon facts and analysis presented in the staff report and the attachments thereto, the public testimony received, and subject to the Conditions of Approval listed below, the Planning Commission makes the following findings:

- 1. The project is consistent with the adopted codes, policies, standards and plans of the City; and
- 2. The proposed development plan will not be detrimental to the health, safety, morals, comfort, convenience and general welfare of the residents and or businesses in the surrounding area, or be injurious or detrimental to property and improvements in the neighborhood or to the general welfare of the City; and
- 3. The proposed development plan accommodates the aesthetic quality of the City as a whole, especially where development will be visible from the gateways to the City, scenic corridors; and the public right-of-way; and

- 4. The proposed development plan is compatible with, and is not detrimental to, surrounding land uses and improvements, provides an appropriate visual appearance, and contributes to the mitigation of any environmental and social impacts; and
- 5. The proposed development plan is compatible with existing scenic and environmental resources such as hillsides, oak trees, vistas, etc.; and
- 6. The proposed development plan contributes to the orderly development of the City as a whole; and
- 7. The proposed development plan as conditioned would meet the intent of the General Plan and Zoning Ordinance by providing the opportunity for clean attractive business to be located in the Business Park/Planned Industrial designated areas of the City; and
- 8. Modifying the primary fuel island canopy for Eagle Energy/76 Fuel Sales, to a standard aluminum façade syle, would be simiar to the two other fuel canopies located at the fuel sales business across Golden Hill Road and would seem reasonable at the intersection of Highway 46 East and Golden Hill Road, since no specific architectural character has been established.




