PUBLIC HEARINGS -

1. <u>Conditional Use Permit 15-018 – Tracey Burns – 1311 Chestnut Street – Oversized</u> <u>Accessory Structure and Height Exception (APN: 009-021-039)</u>

For the Planning Commission to consider an application filed by Wade Tucker, on behalf of Tracey Burns for a Conditional Use Permit (CUP) to allow the construction of an accessory structure that exceeds 50-percent of the gross floor area of the primary dwelling and exceeds the 15-foot height limit, thereby allowing a guest house addition to an existing detached garage.

percent of the primary residence, taller than 15- feet, and continue to have an existing non-conforming side yard setback less than 3-feet, subject to standard and site specific conditions of approval.

2. <u>Two (2) Lot Tentative Parcel Map PR 15-0081, 544 Oak Street (Applicant: Bonelli)</u> <u>APN: 009-257-001</u>

For the Planning Commission to consider a two (2) lot Vesting Tentative Parcel Map PR 15-0081 filed by William Bonelli, to subdivide a 7,000 square foot parcel into two parcels of 3,558 and 3,439 square feet, where each of the existing homes would be on separate parcels.

3. <u>Conditional Use Permit 15-021 (Boy Scouts) New 2,736 SF Meeting Facility – 2247 Oak</u> <u>Street</u>

For the Planning Commission to consider an application filed by Nick Gilman on behalf of the Boy Scouts, requesting to amend CUP 64-002 to remove the existing 1,000 square foot meeting facilities building and replace it with a new 2,736 square foot meeting facilities building. (APN: 008-162-005)

New Condition 6: **Prior to the issuance of a building permit, the City Consent of Landowner form shall be provided that indicates the owner(s) of record of the fee interest of the property, and acknowledges their consent of the processing of a building permit for the property.**

4. <u>Conditional Use Permit 15-019 Indoor Sports Use (Billiards Club) – Crimson Cue,</u> <u>Skupien – 1319 Spring Street (APN: 009-037-010)</u>

For the Planning Commission to consider a request filed by Erik Skupien, to establish an indoor sports use for a billiards club on the second floor within the existing building located at 1319 Spring Street.

Condition 1: This Conditional Use Permit (CUP) authorizes the establishment of a billiards club (Indoor Sports use) on the second floor of the building at 1319 Spring Street. <u>The hours of operation will be 11:00am to 12:00am Sunday through Thursday and 11:00am to 2:00am Friday and Saturday</u>.
