continuity between the new structure and the existing building, especially since this is a gateway to the City for pilots and others visiting the area. The DRC also indicated the color of the patio cover shall match the existing color of the fascia of the building.

storefront windows on a building listed on the City's Historic Building Inventory.

Discussion: The architect, Don Love, reviewed the project request, indicating the building has

been updated in the past, however, the new storefront windows would be designed consistent with the current architecture of the building. The DRC agreed that although the building has changed over time and appears to have lost its historic authenticity, the proposed storefront windows are consistent with the architecture of

the building, and supported issuance of a Certificate of No Effect.

Action: The DRC unanimously approved the exterior changes to the building by granting the

applicant a Certificate of No Effect, as described in the City's Historic Preservation

Ordinance.

Discussion: The sign designer, Tim Bauman, explained the Master Sign Plan for the individual

tenant spaces, clarifying the tenant facing the alley would have a flat wall-mounted sign and the interior tenants fronting the courtyard would each have a projecting sign. Per the sign plan, each future tenant would be required to stay consistent with the approved materials, which allows for white lettering on a black powder coated plate. The DRC indicated that if a building directory sign is proposed in the future, it could

be reviewed by staff for consistency.
