- Brian O'Kelly stated concerns with the quantity of 7,000 square foot lots that could be allowed.
- Mike Meneth posed questions.
- Dale Gustin expressed questions and concerns.

Action: A motion was made by Commissioner Finigan, seconded by Commissioner Johnson, and passed 4-2-1 (Commissioners Steinbeck and Ferravanti abstained, Commissioner Warnke absent), which interprets the Union/46 Specific Plan to maintain lot sizes at 10,000 square feet but that an applicant may apply for reduced lot sizes of not less than 7,000 square feet via the Planned Development process.

Commissioner Ferravanti resumed his seat on the dais. Commissioner Steinbeck remained off the dais. Commissioner Nemeth retained the Chair.

# 8. **DISCUSSION OF MULTI-FAMILY DEVELOPMENT REGULATIONS**

**Action:** Following discussion, a motion was made by Commissioner Johnson, seconded by Commissioner Tascona, and passed 5-1-1 (Commissioner Steinbeck abstained, Commissioner Warnke absent), to recommend a set of new code standards that reflect the straw vote consensus of the Planning Commission.

Action: Following discussion, a motion was made by Commissioner Johnson, seconded by Commissioner Nemeth, and passed 6-0-1 (Commissioner Warnke absent), to recommend that the City Council adopt the Redevelopment Implementation Plan with the priorities for use of Low and Moderate Income Housing Funds as outlined in the original draft (not as proposed for revision by the Project Area Committee).
