- Jane Janice stated that she is opposed to expansion of the City's Sphere of Influence along Creston Road; sees a sphere expansion as agricultural land consumption; expressed concerns over traffic, school and water impacts; water impacts; and sees the City circling Spanish Camp. In her opinion expansion should be east not south.

Action: A motion was made by Commissioner Johnson, seconded by Commissioner Finigan, and passed 6-0-1 (Commissioner Nemeth absent), to recommend City Council consideration of the 5,000 and 10,000 population increases beyond the General Plan build-out of 35,000 and that growth be planned for the area between Linne and Creston Road, puls that the study area should include the area up to and including the Wellsona/Hwy 101 intersection as a part of the application for the Sphere of Influence Amendment.
