- Commissioner Warnke stated that she will need someone else to cover for her at DRC Meetings through the end of August. She also stated that she will not be present for the July 23, 2002 Planning Commission Meeting. Commissioner Warnke also asked about the status of the Jiffy Store Signage Code Enforcement issue.
- Commissioner McCarthy stated that there is continually a shortfall of Commissioners for attendance at DRC Meetings and that we need to establish a new/different system to assign members to attend. Following discussion it was determined that Commissioners Johnson, Warnke and McCarthy would be the regular DRC members and that Commissioners Ferravanti and Calloway would be the alternate members.
