He also stated that road patchwork after construction is not adequate and suggested that the City should establish specs and a warranty program for road finishing. Commissioner Ferravanti also expressed concern for a set of speed limits along the Creston Road corridor. He also asked if DRC Meetings could be held at a different time/day so that more Commissioners would be able to attend.
