1. **FILE #:** **SPECIFIC PLAN AMENDMENT 12-002**
 APPLICATION: To conduct a semi-annual review of the Uptown/Town Centre Specific Plan and make a recommendation to the City Council to consider approval of amendments to the plan.

 APPLICANT: City of Paso Robles
 LOCATION: Generally located west of the Salinas River, east of Vine Street, and between 1st and 38th Streets.

Action: A motion was made by Commissioner Treach, seconded by Commissioner Peterson, and passed 5-0-2 (Commissioners Barth and Gregory absent), to recommend that the City Council approve the Negative Declaration as presented.

Action: A motion was made by Commissioner Treach, seconded by Commissioner Peterson, and passed 5-0-2 (Commissioners Barth and Gregory absent), to recommend that the City Council approve the amendment to the Uptown/Town Centre Specific Plan with the following changes:

- (1) Retain the following public improvement projects as long-range projects:
 - (a) Pedestrian bridge over Highway 101 at 12th Street;
 - (b) Equestrian underpass under Highway 101 at Pioneer Park;
 - (c) At-grade pedestrian railroad crossing at 28th Street.
- (2) Reset the standard for the size of a community room for a multi-family residential project with 32 or more units from 40 square feet per unit to 20 square feet per unit, provided that the minimum size for any community room would be 1,200 square feet.

2. FILE #: **CERTIFICATE OF APPROPRIATENESS
12-002, VARIANCE 12-001, OAK TREE
REMOVAL 12-009 AND WAIVER 12-002**

APPLICATION: To consider making recommendations to the City Council for the approval of the Certificate of Appropriateness, Variance, Oak Tree Removal and Waiver applications. The Planning Commission will also be considering the content and potential application of any conditions of approval that relate to the subject application.

- 3. **FILE #:** **CONDITIONAL USE PERMIT 12-008**
- APPLICATION:** To consider an application to establish and operate a church within an existing building. The Planning Commission will also be considering the content and potential application of any conditions of approval that relate to the subject application.
- APPLICANT:** Newday Church
- LOCATION:** 530 12th Street
(APN: 009-093-061)

Staff explained that, since the staff report was prepared, it re-evaluated the parking requirements and determined that, as a “non-residential building” in the Uptown/Town Centre Specific Plan, the site was nonconforming regarding off-street parking, and that the church could occupy the building without any requirement to obtain additional parking spaces off-site. Staff added that (a) Condition #1 should be revised to delete the second half of the condition, which begins with “and approves the use of off-site parking...” and (b) Condition #3 should be deleted.

Action: A motion was made by Commissioner Vanderlip, seconded by Commissioner Holstine, and passed 5-0-2 (Commissioners Barth and Gregory absent), to approve Conditional Use Permit 12-008 with the change to Condition #1 that deletes the second half of the condition, which begins with “and approves the use of off-site parking...” and the deletion of Condition #3.
