I appreciate you taking the time to talk to me regarding the proposed 141-unit apartment complex on Experimental Station Road in Paso Robles. Per our conversation, please forward the following letter to the appropriate recipients as I am unable to attend the meeting on Tuesday due to my recent surgery. Thank you in advance.

Dear Paso Robles Planning Commission,

My family and I are strongly opposed to the proposed 141-unit apartment complex on Experimental Station Road in Paso Robles.

We have first-hand experience with the negative impact on a neighborhood when “affordable rental housing” is added to a single family home neighborhood. In addition to the obvious traffic and parking problems, home values plummet, the schools go downhill (including negatively impacting school scores and overcrowding), and crime rates skyrocket.

We purchased our home in the River Oaks community for many reasons, including the ability for our children to attend the highly rated school (Kermit King Elementary), the low crime rate in our neighborhood, the layout and feel of the neighborhood (not crowded like in the city), as well as the pride in home ownership that our community so proudly boasts. My family and I feel safe while walking and riding bikes through our community.

The addition of 141-units could cause a traffic nightmare as there is only 1 main way in and out of our neighborhood (the other options are either very inconvenient, or unsafe in inclement weather). It would create a major overcrowding problem at Kermit King Elementary as it is already very crowded and there is potential to add hundreds of children with the addition of an apartment complex. Our children's education is not something we take lightly. As you are aware, home prices have plummeted due to the economic downturn, and having our home values drop further is not an option for many of us homeowners.

We understand the property in question was changed from “single family” to “multi-family” in 2003. We would welcome townhomes (and possibly condominiums) on Experimental Station Road as these are owned by the occupants where there will be pride in ownership as well as have less of a negative impact on the issues raised above such as overcrowding and loss of home values.
