1. **Conditional Use Permit 12-010 – NCI Affiliates, Inc.**

For the Planning Commission to open the public hearing, continued from October 23, 2012, to consider an application filed by NCI Affiliates, Inc. to re-establish staff training programs and executive offices within the Chestnut House located at 1434 Chestnut Street.

Options:

- a. Adopt the resolution approving the proposed Conditional Use Permit 12-010, subject to standard and site specific conditions of approval;
- b. Amend, modify, or reject the above option.

2. **Planned Development 12-006 – (Firestone Walker, LLC)**

For the Planning Commission to consider an application filed by Firestone Walker LLC, proposing to construct a new 40,000 square foot expansion building and a new surface parking lot at 1400 Ramada Drive.

Options:

- a. 1) Adopt the resolution approving a Mitigated Negative Declaration for Planned Development 12-006, subject to the mitigation measures identified in the resolution approving Planned Development 12-006;
- 2) Adopt the resolution approving Planned Development 12-006, allowing the construction and operation of the new 40,000 square foot building for Firestone Brewery, along with the new parking lot, subject to standard and site specific conditions;
- b. Amend, modify, or reject the above option.

3. **General Plan Amendment 12-003 – Land Use, Circulation and Conservation Elements, Post-Construction Storm Water Management Policies**

For the Planning Commission to make a recommendation to the City Council to initiate an amendment to the text of the Land Use, Circulation, and Conservation Elements of the General Plan to establish policies in support of on-site Low Impact Development post-construction storm water management.
