#### OTHER SCHEDULED MATTERS

1. <u>Allotment of Additional Dwelling Units and Specific Plans Processing</u>
E. Gallagher, Community Development Director

For the Planning Commissioners to make a recommendation to the City Council whether to allot up to 594 additional dwelling and revising priorities for preparing and amending Specific Plans (as currently set forth in Resolution 09-055).

#### **Options:**

- **a.** Recommend that the City Council adopt the attached Resolution Updating and Superseding Resolution 09-055 Regarding Providing Direction and Processing Priorities for Various Specific Planning Efforts;
- **b.** Amend, modify, or reject the above option.

**Action:** A motion was made by Commissioner Gregory, seconded by Commissioner Barth, and passed 6-0-1 (Commissioner Nash absent) to recommend the following:

- 1. Make no allocation of any of the 594 units prior to completion of specific plans or amendments to existing specific plans and their attendant environmental documents.
- 2. Make processing of specific plans (and amendments thereto) a priority for the City.
- 3. Look for ways to increase the number of additional units beyond 594. For example, increase the vacancy rate to 6.2% to match the State/Federal vacancy rate, and/or make assumptions that many (more) properties will not develop to their maximum potential. (Parenthetically, I said "more" as General Plan Amendment 2005-001 included an assumption that 425 potential units scattered across a large number of parcels city-wide would not be built.)
- 4. City should take the initiative to evaluate the actual capacity of its infrastructure systems to see if they can support a greater population. For example, the water system is designed to accommodate a population of 44,000, but conservation efforts, including the landscaping ordinance are reportedly decreasing the amount of water used, and this should expand they system's capacity to accommodate more population. (If the City does not "take the initiative" in this matter, the applicants' EIR consultants would do this research at the applicants' cost, although I suspect that staff will spend a considerable amount of time in this research effort, regardless of who initiates it.)
- 5. Authorize the hiring of contract planners if necessary to ensure specific plans are processed expeditiously.
