If any protected species are found on the site, the project biologist shall identify and implement measures necessary to reduce impacts, in accordance with applicable State and/or Federal regulations (e.g. Endangered Species Act).
 - #19. Vehicular and service/utility access to existing residences shall be maintained throughout development of the tract.
