1. **STREET ABANDONMENT 15-001 (ST. ROSE CATHOLIC CHURCH)**
CONTINUED FROM FEBRUARY 23, 2016 PLANNING COMMISSION

2. **PLANNED DEVELOPMENT 16-001 & OAK TREE REMOVAL 16-003**
APN: 008-031-029, 030 & 033 (SOUTHEAST CORNER OF 36TH & OAK –
WEBB)

For the Planning Commission to consider an application for a development plan (PD) filed by Warren Hamrick on behalf of Jim Webb, proposing to construct a ten-unit apartment complex and request that the Planning Commission make a recommendation to the City Council for removal of two oak trees.

- b. A motion was made by Commissioner Barth, seconded by Commissioner Donaldson and passed 6-0-1 (Absent: Davis) to adopt Draft Resolution B recommending that the City Council approve the request to remove the two oak trees within the 36th Street right of way, subject to replacement requirements;
