A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF PASO ROBLES GRANTING NEGATIVE DECLARATION STATUS FOR DEPARTMENT OF PUBLIC WORKS PROJECT 99-13 - STREET RESURFACING (APPLICANT: CITY OF PASO ROBLES)

WHEREAS, the City has initiated an application with the State of California for funding to accomplish a street resurfacing project for four (4) segments of public street within the City of Paso Robles, and

WHEREAS, the four street segments proposed for pavement resurfacing are: Vine Street, between 1st and 32nd Streets; North River Road, between Creston Road and the northern City limits; 24th Street, between Highway 101 and Park Street; and Charolais Road, between Arbolado Road and Creston Road, and

WHEREAS, an Initial Study was prepared for this project and concluded that the preparation of a Draft Negative Declaration was appropriate for this project, and

WHEREAS, the Draft Negative Declaration was circulated for a period of 30 days, in accordance with the California Environmental Quality Act (CEQA), and

WHEREAS, a public hearing was held by the Planning Commission on June 8, 1999 (during the 30 day public comment period for the Draft Negative Declaration) and at that meeting there were comments received from Planning Commissioners regarding the Draft environmental document, but no comment provided by the general public, and

WHEREAS, a letter was received from the San Luis Obispo County Air Pollution Control District, dated June 4, 1999, recommending a modification to one of the mitigation measures relating to dust control during construction, and

WHEREAS, modifications were made to the project's mitigation measures in accordance with the comments received, and

WHEREAS, the Planning Commission held a second (continued) public hearing on June 22, 1999 to accept public testimony and consider the revised Negative Declaration document for this project, and

WHEREAS, based on the information contained in the Initial Study prepared for this project and testimony and public input received as a result of the public notice, the Planning Commission finds no substantial evidence that there would be a significant impact on the environment if the application was approved with mitigation measures as described in that initial study and contained in the Mitigation Table attached as Exhibit A to this resolution.
