ROLL CALL VOTE. Motioned by Councilmember Hamon, seconded by Councilmember Strong, and passed unanimously to introduce for first reading, by title only, an Ordinance approving updates and revisions to the City's parking regulations, contained in Title 12, *Vehicles and Traffic*, and Title 5, *Business Licenses*, of the Paso Robles Municipal Code.

12. Employee Parking Permit Pilot Program

ROLL CALL VOTE. Motioned by Councilmember Strong, seconded by Councilmember Gregory, and passed unanimously to approve the Downtown Employee Parking Permit Pilot Program and authorize the City Manager to enter into agreements with vendors IPS Group and Vigilant Solutions to provide technology services necessary to support the program. Amended to direct that the consultant start the pilot program with 150 parking permits for sale (instead of 75 permits) and that staff report back to City Council monthly regarding the progress of the pilot program.

15. Acceptance of Phase 4 Final Map of Tract 3024 – Phase IV, Oak Park Phase 4 (PR LLC, Housing Authority of the City of Paso Robles) for Recordation

PUBLIC COMMENT. Francisco Ramirez

ROLL CALL VOTE. Motioned by Councilmember Gregory, seconded by Councilmember Strong, and passed unanimously to approve the Final Map for Tract 3024 – Oak Park Phase 4 by the following actions:

- a. Approved Resolution No. 18-148 authorizing execution and recordation of the Final Map for Tract 3024–Phase 4, accepting the offers of dedication for streets and blanket public utility easements (PUE) as shown on the Map to the terms of offer of dedication by the parties having a record interest in said land. Order the abandonment of those portions of Pine Street, 34th Street, Park Street, sewer easement, and the PUE'S within Phase 4 of the map.
- b. Direct the City Clerk to state the following on the map "I, Dennis Fansler, City Clerk of the City of El Paso de Robles, California, hereby state that the City Council of Said City did on October 16, 2018, approve the map of Tract 3024-Phase 4 shown hereon and accepts the offer of dedication for streets and public utility easements (PUE) as shown on this map, to the terms of offer of dedication by the parties having record title interest in said land. I also do hereby state that the City Council did hereby order the abandonment of those portions of Pine Street, 32nd Street, sewer easement, and the PUE'S within Phase 4 of this map, and the same is hereby abandoned in accordance with Government Code Section 66834(g) with the filing of this map."
- c. Authorize the City Manager to enter into a Subdivision Improvement Agreement and sign a Consent to Collateral Assignment of Subdivision Improvement Agreement prior to recordation of the Final Map of Tract 3024-4.

16. Public Private Partnership for Road Repairs on Ramada Drive

Motioned by Councilmember Hamon, seconded by Councilmember Gregory, and passed unanimously to direct the City Manager and City Attorney to finalize an improvement/reimbursement agreement with Firestone Walker, Inc., consistent with overall Council direction; allocate funds already approved for the remaining six-year road plan to this project, sufficient to reimburse Firestone Walker for those amounts not being invested by Firestone Walker and other businesses along Ramada for up to \$379,000 of total project costs.
